Providers are able to supply documentary evidence of DAF Funding eligibility by simply uploading evidence to the child's record under the 'Documents' section. Please refer to 'UPLOADING DOCUMENTS TO PUPIL REGISTER' on how to do this.

Once documentary evidence has been supplied the Provider should notify Waltham Forest's Early Years & Child Care team by emailing 'childcare@walthamforest.gov.uk'.

A member of our team will them review documents and then, upon confirmation, will then supply a unique code to the provider. Providers should record this code in the 'Funded Early Learning Ref' field in the 'Pupil Details' section of the child's record.
